

# **LAGOTTO ROMAGNOLO CLUB OF GREAT BRITAIN**

## **JUDGING CRITERIA FOR A3 and B LISTS - 2023**

### **A3 List (Breed Specialists)**

- a. To have a minimum of seven years judging experience of Lagotto Romagnolo.
- b. Preferably to have judged Lagotto Romagnolo at one Breed Club Open Show, or Special Award Classes at a Breed Club Open Show, or one Championship Show without CCs.
- c. To have judged a minimum of 40 Lagotto Romagnolo.
- d. To have attended a seminar given by a Kennel Club Accredited Trainer and passed the Kennel Club examination 'Requirements of a Dog Show Judge' (sometimes known as 'Rules and Regulations') (existing CC Judges excepted).
- e. To have attended a seminar given by a Kennel Club Accredited Trainer on 'Conformation and Movement' (existing CC judges excepted).
- f. To have passed a 'Points of the Dog Assessment' conducted by a Kennel Club Accredited Trainer (existing CC judges excepted).
- g. To have:
  - attended at least one Breed Specific Seminar or Breed Appreciation Day on the Lagotto Romagnolo organised by a breed club;
  - passed the multiple-choice examination (MCE) on Lagotto Romagnolo; and
  - passed a Lagotto Romagnolo hands-on breed assessment organised by a breed cluball of which have been run in accordance with the relevant Kennel Club Code of Best Practice.
- h. To have bred and/or owned a minimum of three Lagotto Romagnolo when they obtained their first entry in the Kennel Club Stud Book (if and when applicable).
- i. To have stewarded at a minimum of 12 Shows.
- j. To have attended any Field Trial (FT) or an Open Gundog Working Test (GWT) for a Spaniel breed (one time qualification).
- k. To have the support of the Lagotto Romagnolo Club of Great Britain.

<p><b>Overseas Judges</b> will be considered for inclusion on the A3 judging lists based on their experience with Lagotto Romagnolo and in line with KC guidance. The candidate must be approved to award the equivalent of Challenge Certificates (CCs) in their Country of Residence.</p>

### **A3 List (Non-Breed Specialists)**

- a. To have a minimum of seven years judging experience in any one breed (to include at least five years in Lagotto Romagnolo).
- b. Preferably to have judged Lagotto Romagnolo at one Breed Club Open Show, or Breed Club Special Award classes at a Breed Club Open Show, or one Championship Show without CCs.

- c. To have judged a minimum of 40 Lagotto Romagnolo.
- d. To have awarded CCs in at least one other breed, preferably a Gundog breed.
- e. To have:
  - attended at least one Breed Specific Seminar or Breed Appreciation Day on the Lagotto Romagnolo organised by a breed club;
  - passed the multiple-choice examination (MCE) on Lagotto Romagnolo; and
  - passed a Lagotto Romagnolo hands-on breed assessment organised by a breed club (excepting judges who already award CCs in three breeds)all of which have been run in accordance with the relevant Kennel Club Code of Best Practice.
- f. To have the support of the Lagotto Romagnolo Club of Great Britain.

### **B List (Breed Specialists)**

- a. To have a minimum of five years experience of owning, exhibiting and/or breeding Lagotto Romagnolo.
- b. To have judged/examined a minimum of 10 Lagotto Romagnolo.
- c. To have:
  - attended at least one Breed Specific Seminar or Breed Appreciation Day on the Lagotto Romagnolo organised by a breed club; and
  - passed the multiple-choice examination (MCE) on Lagotto Romagnoloall of which have been run in accordance with the relevant Kennel Club Code of Best Practice.
- d. To have attended a seminar given by a Kennel Club Accredited Trainer and passed the Kennel Club examination 'Requirements of a Dog Show Judge' (sometimes known as 'Rules and Regulations') (existing CC Judges excepted).
- e. To have attended a seminar given by a Kennel Club Accredited Trainer on 'Conformation and Movement' (existing CC judges excepted).
- f. To have passed a 'Points of the Dog Assessment' conducted by a Kennel Club Accredited Trainer (existing CC judges excepted).
- g. To have stewarded at a minimum of two Shows (existing CC judges excepted).
- h. To have the support of the Lagotto Romagnolo Club of Great Britain.

<p><b>Overseas Judges</b> will be considered for inclusion on the judging lists based on their experience of Lagotto Romagnolo in their Country of Origin and in line with KC guidance.</p>

### **B List (Non-Breed Specialists)**

- a. To have a minimum of five years judging experience of any breed.
- b. To have judged /examined a minimum of 10 Lagotto Romagnolo.

c. To have:

- attended at least one Breed Specific Seminar or Breed Appreciation Day on the Lagotto Romagnolo organised by a breed club; and
- passed the multiple-choice examination (MCE) on Lagotto Romagnolo

all of which have been run in accordance with the relevant Kennel Club Code of Best Practice.

d. To have attended a seminar given by a Kennel Club Accredited Trainer and passed the Kennel Club examination 'Requirements of a Dog Show Judge' (sometimes known as 'Rules and Regulations') (existing CC Judges excepted).

e. To have attended a seminar given by a Kennel Club Accredited Trainer on 'Conformation and Movement' (existing CC judges excepted).

f. To have passed a 'Points of the Dog Assessment' conducted by a Kennel Club Accredited Trainer (existing CC judges excepted).

g. To have stewarded at a minimum of two Shows (existing CC judges excepted).

h. To have the support of the Lagotto Romagnolo Club of Great Britain.

**Note: In accordance with KC Guidance, any Gundog Group Judge is automatically qualified as a B list Judge for any breeds within that Group that they do not already award CCs in.**

**All applications to the LRCGB judging lists must receive a vote of at least 75% from the Judging Sub-Committee and have their support.**
